#### **Restarting safely**

Summer has always been synonymous with freedom, travel and relaxation. This year it also wants to become synonymous with normality, the one that we have missed in recent months and that we want to reclaim by taking up spaces and habits of the past.

Our goal is to give you the chance to live your vacation without worries and because of this we engaged with important efforts to secure its structures. Nevertheless, in order to aim to our goal, we're forced to ask your cooperation by respecting some simple behavioural rules for sharing common areas such as children's play area, swimming pools, barbecue, etc.

The Lampo Group staff is at your disposal for any doubt or observation you might have.

#### Access to the structure

The access is prohibited to whom:

- Has fever (> 37,5°C)
- Has flu symptoms (i.e. cough, breathing difficulties)
- Have had contact within the last 14 days with people positive to COVID-19



### General rules for common spaces

All the areas sheared by members of different families during the stay are considered common spaces. The following general rules are therefore applied:

- Avoid gatherings of peoples and keep the interpersonal distance of at least 1 mt (this obligation does not apply to cohabitants)
- Avoid hands shakes and hugs
- Wash your hands often. Dispensers with sanitizing gel are available.
- Cover your mouth and nose if you sneeze
- You are obliged to always wear the mask in closed and open common spaces only if the distance is less than 1 meter



# Swimming-pool access

- Do not enter the swimming-pool in case of fever (>37,5°C) or flu symptoms
- Any additional guests must be communicated to the administrator
- Avoid gatherings of people and keep the minimum of 1 mt distance, even inside the showers area
- Clothes and personal belongings must be stored inside your bag
- Sanitize your hands frequently using the appropriate dispensers
- Respect the maximum crowding of the tank as indicated by the signs
- Do not move the sun umbrellas (the granted surface must be of at least 10 squared meters for each one)
- Between the beds without umbrella, ensure a distance of at least 1.5 meters
- Disinfect the sun-beds before and after your use using the sprayers provided (to be used only by adults)
- Very young children will need to wear containment diapers
- To take a soap shower is compulsory in accordance with the regional directives in force
- It is forbidden to spit
- Supervise your children in accomplice with the given indications

Staff checks are possible but it is necessary to rely on individual responsibility



#### **Playground Area**

Parents are invited to self-monitor the health conditions of their family and to inform children about the behaviors to adopt.

- Avoid gathering in the playground areas
- Keep at least 1 mt distance, except within family members
- Face mask must be used by adults and children over 6 years of age
- Sanitize your hands often
- The area will be disinfected on a multi-daily basis.
